

With these COVID rules you'll spend your holidays in Paznaun safely.

Entry only with the 2G-rules: Vaccinated - recovered

in all accommodations, culinary establishments, leisure and sports facilities, shops, museums, body-hugging services and at events

Vaccinated:

- Proof by means of immunisation passport, immunisation card or print-out
- From the **second vaccination** (must not be more than **270 days** ago)
- Vaccination valid **immediately** if a **positive COVID-test** was completed at least **21 days** before vaccination, or a **positive antibody test** immediately before vaccination (The vaccination must not be more than **270 days** ago)
- After **another vaccination** (booster vaccination; must not be more than **270 days** ago)

Recovered:

- Up to **180 days** after end of the infection (proof: isolation certificate, medical confirmation)

Exceptions to the 2G rules:

- Children under 12 years (no G proof required)
- For school-age children and young people from Austria and abroad (between 12 and 15 years of age), the „Holiday Ninja Pass“ replaces the 2G certificate. The 3G rule applies.

- Persons who cannot be vaccinated for health reasons (These require a medical certificate and a negative PCR test not older than 72 hours).

Obligation to wear FFP2 masks

- indoors: in **all public areas** in enclosed spaces (In Shops; In restaurants/cafés/inns when you are not seated at your table. In public enclosed spaces of accommodations)
- outdoors: Wherever a 2-meter distance is not possible, e.g., in pedestrian zones, waiting lines, group gatherings etc. (Exception: closest relatives such as partner and children).



Health

If you suspect you have a COVID-19 infection:

- Please remain in your accommodation
- Call Hotline 1450 or the doctor in the respective district

These rules apply in the individual areas:

Catering



- 2G-Rule (Vaccinated - Recovered)
- FFP2 masks are required in enclosed spaces when you are not seated at your table
- Food and beverages must be consumed at tables and not at the bar (Exception: outdoor food stands)
- Registration compulsory for stays longer than 15 minutes
- Closing time at 10 pm
- The night gastronomy remains closed

Accommodation



- 2G-Rule (Vaccinated - Recovered)
- FFP2 masks are required in public enclosed spaces (e.g. Lobby, Lift, etc.) – does not apply to wet rooms such as showers or swimming pools.

Cable Cars



- 2G-Rule (Vaccinated - Recovered)
- FFP2 masks are required in closed and coverable operating equipment (e.g. gondolas, cabins, covered chairlifts).

Leisure facilities



- 2G-Rule (Vaccinated - Recovered)
- FFP2 masks are required in enclosed spaces
- Closing time at 10 pm
- Registration compulsory for stays longer than 15 minutes

Shops



- 2G-Rule (Vaccinated - Recovered) except essential businesses such as supermarkets, chemists, petrol stations, banks
- FFP2 masks are required in enclosed spaces

Body-hugging services

(Hairdressers etc.)



- 2G-Rule (Vaccinated - Recovered)
- FFP2 masks are required in enclosed spaces

Public transport



(Bus, Taxi, etc.)

- FFP2 masks are required

Events



- Closing time at 10 pm
- Registration compulsory for stays longer than 15 minutes

Without assigned and marked seats:

- Maximum limit of 25 people
- 2G-Rule (Vaccinated - Recovered)

With assigned and marked seats:

- 2G-Rule (Vaccinated - Recovered) for up to 500 participants
- 2G+-Rule (Vaccinated - Recovered + negative PCR Test) for up to 1000 participants
- „Booster vaccine“ + negative PCR Test for up to 2000 participants
- 50 people or more: Obligation to notify applies
- 250 people or more: Obligation to report applies

Your host will inform you about additional rules. Before departure, please check with the relevant authorities about the entry requirements in your home country.
